

Instruction sheet

Each document is a stand-alone document. Each document needs to have witness autograph/sign in replace of notary or notarized.

Witness testimonies

Before filling out the forms make sure you are using a blue pen. Remember the way you autograph your documents matter.

When filling out your document, check and make sure the blanks are correct to your current county, country and state you are domicile in. Domicile, where you are currently living and standing on the soil. Please print your full lawful name (First Middle Last) and your current physical address at the top of the page along with a 2x2 passport quality photo.

Your witness must have known you for 7 years. The two witnesses are to be of people ideally having first hand knowledge of who you are and when and where you were born. They should be able to clearly identify you in the picture you provide (friend, family, classmate, long time employers, coworkers, etc.)

Notarizing by witnesses instead of by a Recording Secretary or State of state notary.

1. Your witnesses need to be different from your first witness above. A witness can NOT witness their own document. Just like a Recording Secretary or State of State notary can NOT autograph/sign their own document to notarize them.
2. Don't over think it. These witnesses do NOT need to have known you for 7 years.

Universal Public Declaration

Before filling out the forms make sure you are using a blue pen. Remember the way you autograph your documents matter.

Make sure you picked the appropriate document that fits your needs. There are two versions of this document. There is one for Federal Employees and the other, which is for everyone else. There is a difference between the two. When filling out your document, take your time and follow along with the sample for help. The first few blanks are to be filled out using the information where you were born. (Born Country, Born State and your Date of Birth) Please type your full lawful name (first, middle, last) when referring to you as the Living Soul filling out the document. The next few blanks are going to be where you are currently living and the current date you are autographing the document, followed by your autograph. (domicile country and date of signing)

Notarizing by witnesses instead of by a Recording Secretary or State of state notary.

1. Your witnesses need to be different from your first witness above. A witness can NOT witness their own document. Just like a Recording Secretary or State of State notary can NOT autograph/sign their own document to notarize them.
2. Don't over think it. These witnesses do NOT need to have known you for 7 years.

Universal Public Declaration of Political Status Established under International and National Law

It is my position and declaration that I was born in this country: born country, and within the borders of a sovereign state, and that I have never knowingly and willingly departed from my birthright standing and I declare:

I am of age, competent, and acting without fear or duress. I declare that to the best of my knowledge and according to Witnesses, I was born on the land and the soil of born state on the 1 day of the month of January in the year of 2003, and I claim no other nationality;

I do claim my divine creation approximately nine months prior to the day I was born and claim my unique DNA from the moment of that creation, together with all other attributes and creations of my mind and body;

I do claim my private Given Name, your full name, which is a gift to me, and also claim right of use and trademark and patent as Holder In Due Course over all variations, styles, permutations, orderings, punctuations and derivatives of my Given Name and any other Name associated with me;

I do not accept any foreign emoluments or titles or offices of personhood such as "Mister" or "Missus" or "Doctor" nor do I voluntarily accept any conferred or assumed obligations of any foreign citizenship or contract;

I adopt no political allegiance to any foreign state, prince, nation, king, flag, government, or principality existing outside of or within the borders of my country, except that I may move my household and establish my home in any other sovereign state;

I am living now in the country known as domicile country and I declare my intention to stay in this physical location and within the borders of this sovereign state and to be counted as one of its people;

I hereby scribe my signature as a living being and my thumbprint as proof of my unique and permanent identity and I make manifest this Universal Declaration of Political Status on this 1 day of January in the year of 2024: by: Jane Mary Oryone (signature and thumbprint)
