### Video Summation for the International Court of Justice

Regrettably, we are again being harassed and suffering foreign "state" terrorism. We are unable to attend the open docket of the court in Geneva or New York, but as we are political prisoners we have no recourse but to send our testimony on video. Please see the attached recording:

Our Fiduciary is extremely well-versed in American History and economics and is available for any questions the Court may have about the way in which the Federation of States has been confused with the Confederate States of America, and how our officers and their families have been suppressed, attacked, harassed and misrepresented for over 160 years.

We are not the "Blue Coats" — nor the "Red Coats" — both of those infamous uniforms are British in nature and origin, blue for naval operations, and red for land operations. Our Government did not approve of nor support the removal of Native populations, the so-called Indian Reservation System, Bureau of Indian Affairs, or Residential Schools. All this horror was inflicted by the British Territorial United States Government and its Officers, not the American Government.

We ourselves have been the victims of the British Raj in America.

Happily, our actual nation-states have been able to live honorably and peacefully with over 500 separate and/or related Native Nations under a system of Dual Nationality that has worked well for us.

The hostile foreign and corrupt government we have referenced is well-known to be Great Britain, but the actual points we wish the Court to understand in five minutes or less are:

- (1) We are the original American Government that existed even prior to the adoption of the Federal Constitutions;
- (2) We have been treated very badly by our European Federal Subcontractors who have not honored their good faith service obligations under their respective Federal Constitutions;
- (3) We have suffered and the Native Nations have suffered under the booteels of commercial and/or municipal corporations substituting themselves for our actual government under color of law;
- (4) They have done this via the simple artifice of naming a corporation after us, for example, "the United States of America" — Incorporated, and neglecting to add the word "Incorporated" to their disclosure — thereby being enabled to impersonate our lawful unincorporated government, access our credit, and commandeer the identity, resources, and people of this country;

(5) No Congress ever issued a Declaration of War related to the American Civil War; it remains an illegal and never properly settled Mercenary Conflict that the responsible Parties have continued to their advantage;

(6) Despite all of this, we have never given up and our American Government is still functioning on the land and soil, the water, and the air jurisdictions; we are still here.

We come to the Court for its Witness among the nations of the Earth, for your understanding and your help as living men and women.
