# The 1st Mask: **TERRITORIAL UNITED STATES**

Comprised of **57 INCORPORATED** state franchises:

50 State of States: (State of New Jersey, State of Ohio, State of Wisconsin, etc.)

7 Insular States: Puerto Rico, Guam, Virgin Islands, etc.

Your American Trade Name was stolen to create a **Foreign Situs trust** **without your knowledge or consent**, and after settlement in 1999, those now bankrupt franchises, or “disregarded entities” were renamed.

**It looks like this: JOHN QUINCY ADAMS**

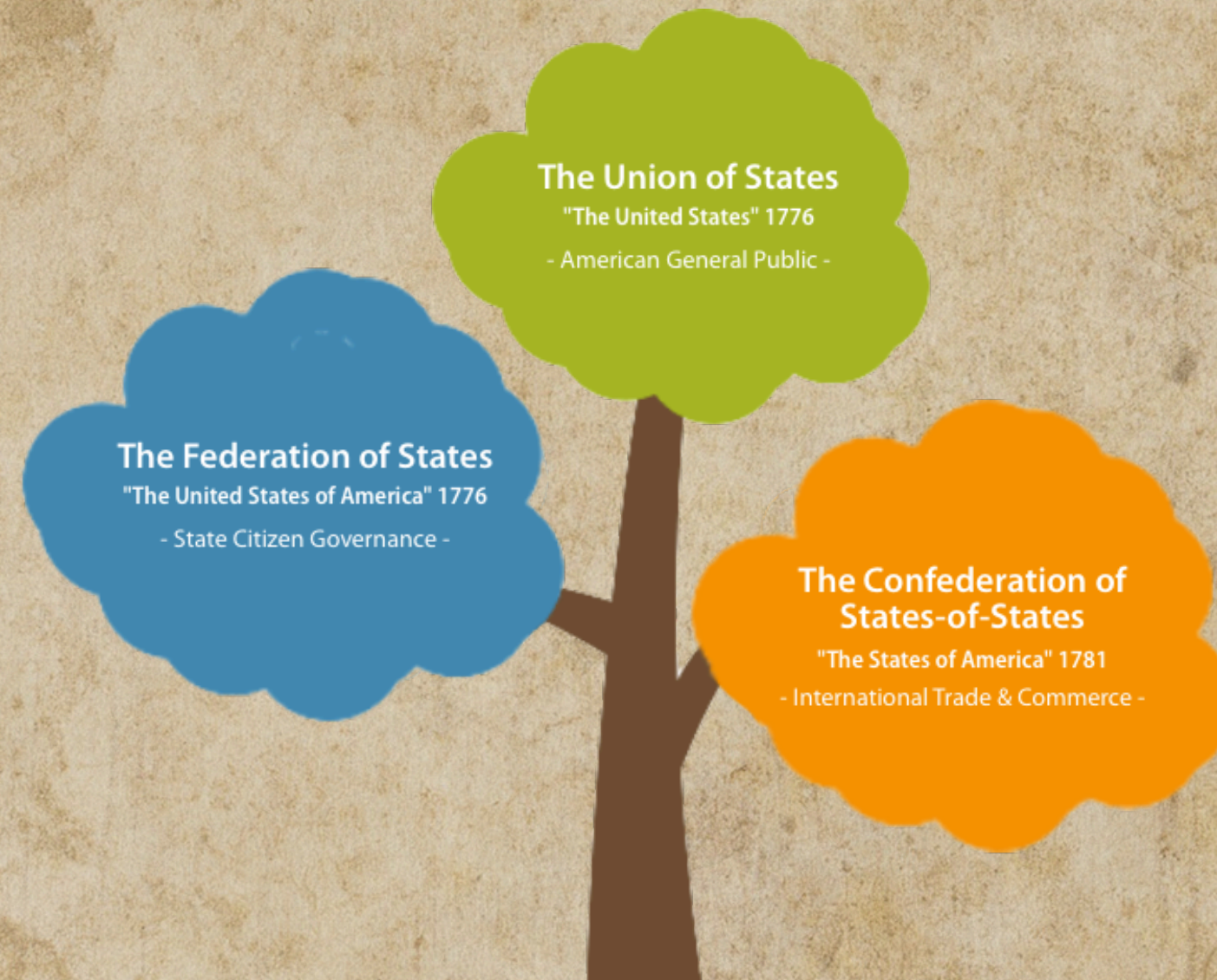

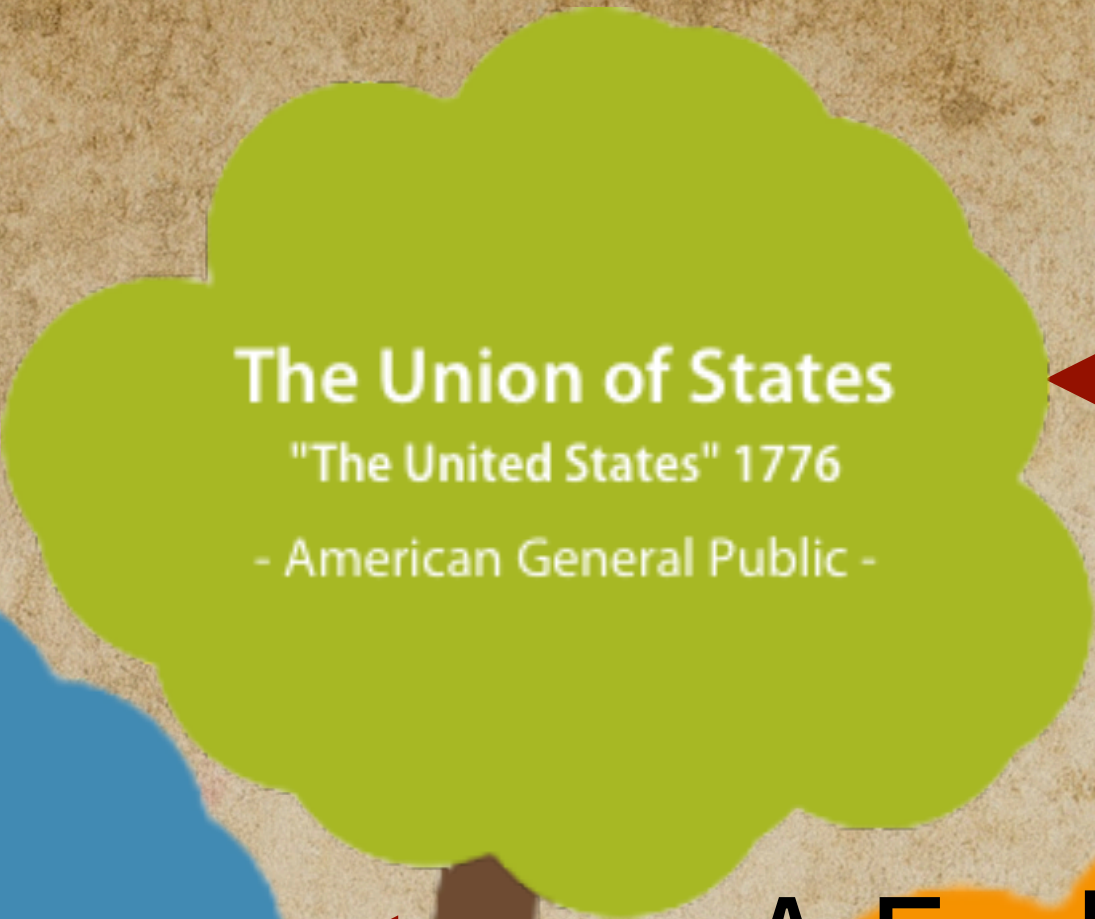
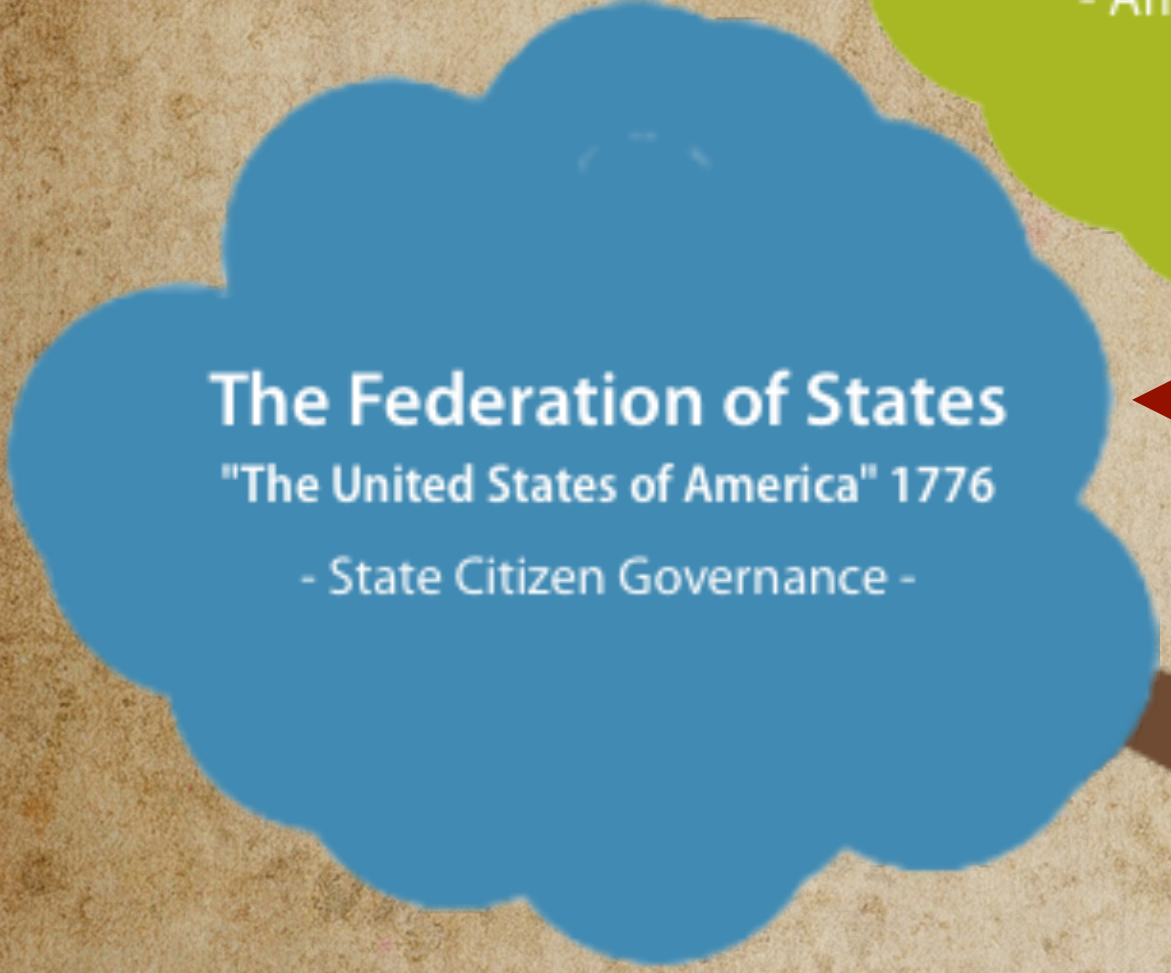

# 1. The Union of States

- Holds the **National Soil Jurisdiction**
- **Nation-States:** virginia, maine, new york (lowercase)
- **State Nationals (people) private persons**
- Inheritors of all American Assets and Credit
- Is the **highest authority** for which all else derives!
- With Constitutional Guarantees and the Law of Peace
- **Is the Living People's County Government & Courts**
- Use the Common Law of the People via Juries

- Uses International Mercantile Law

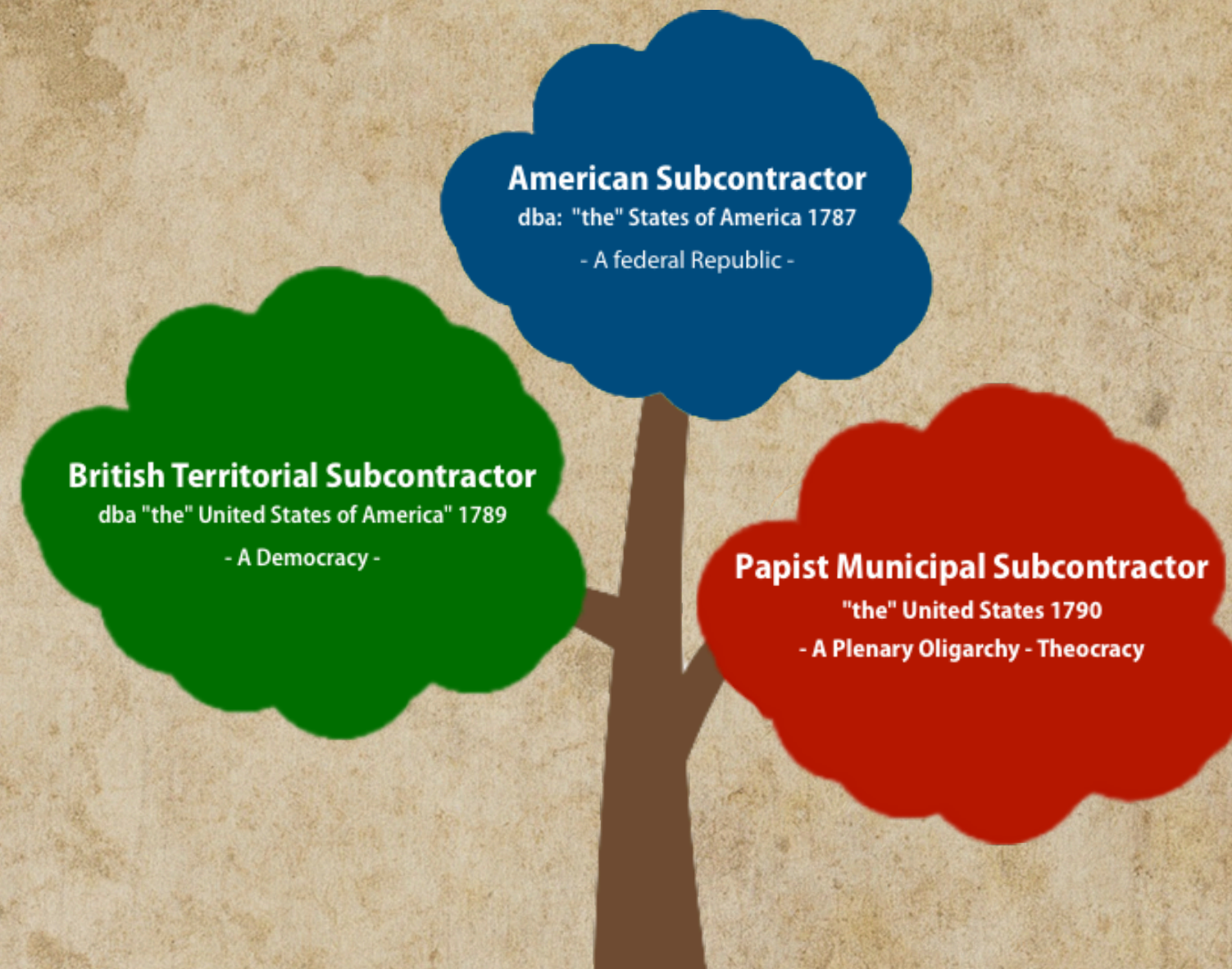

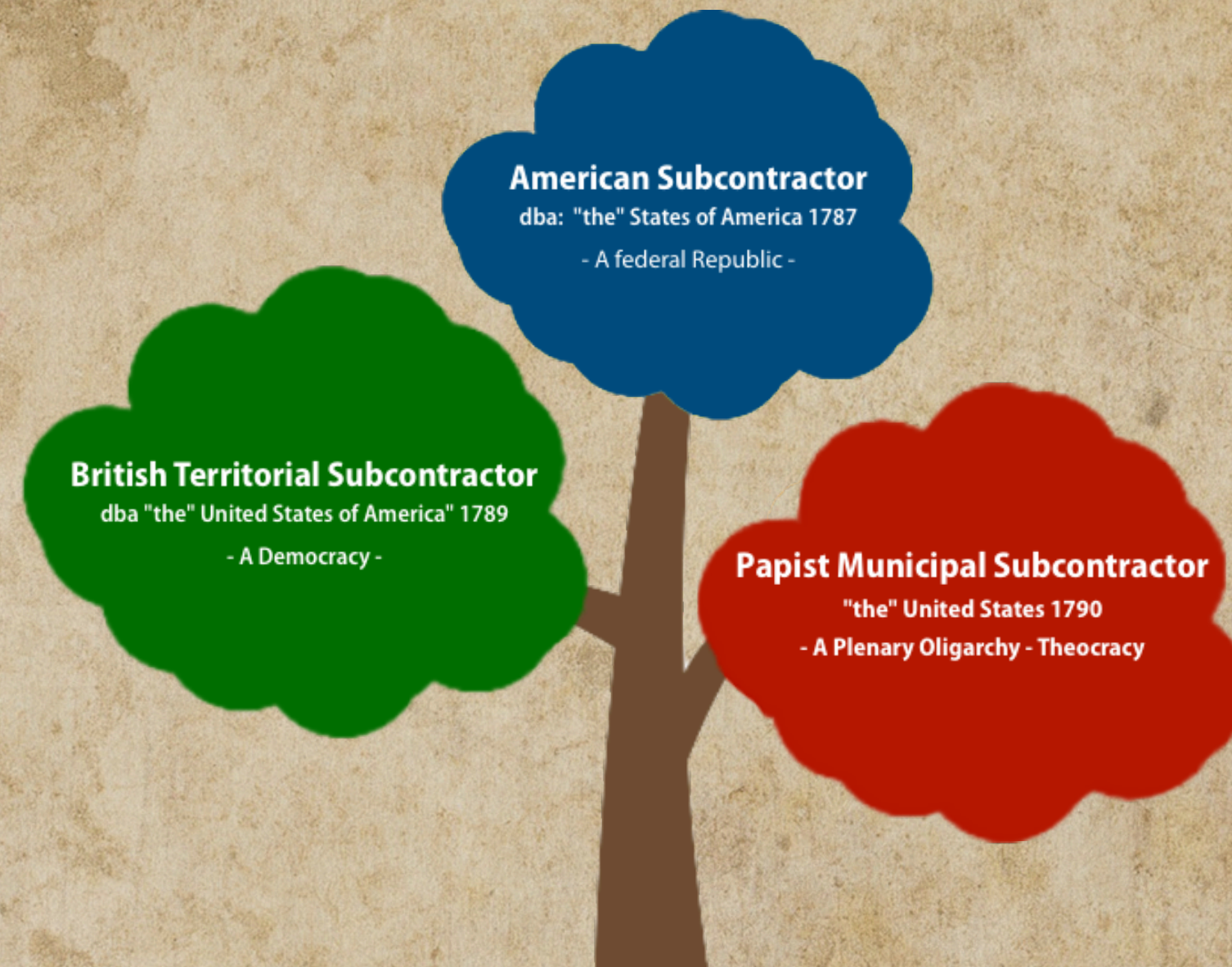

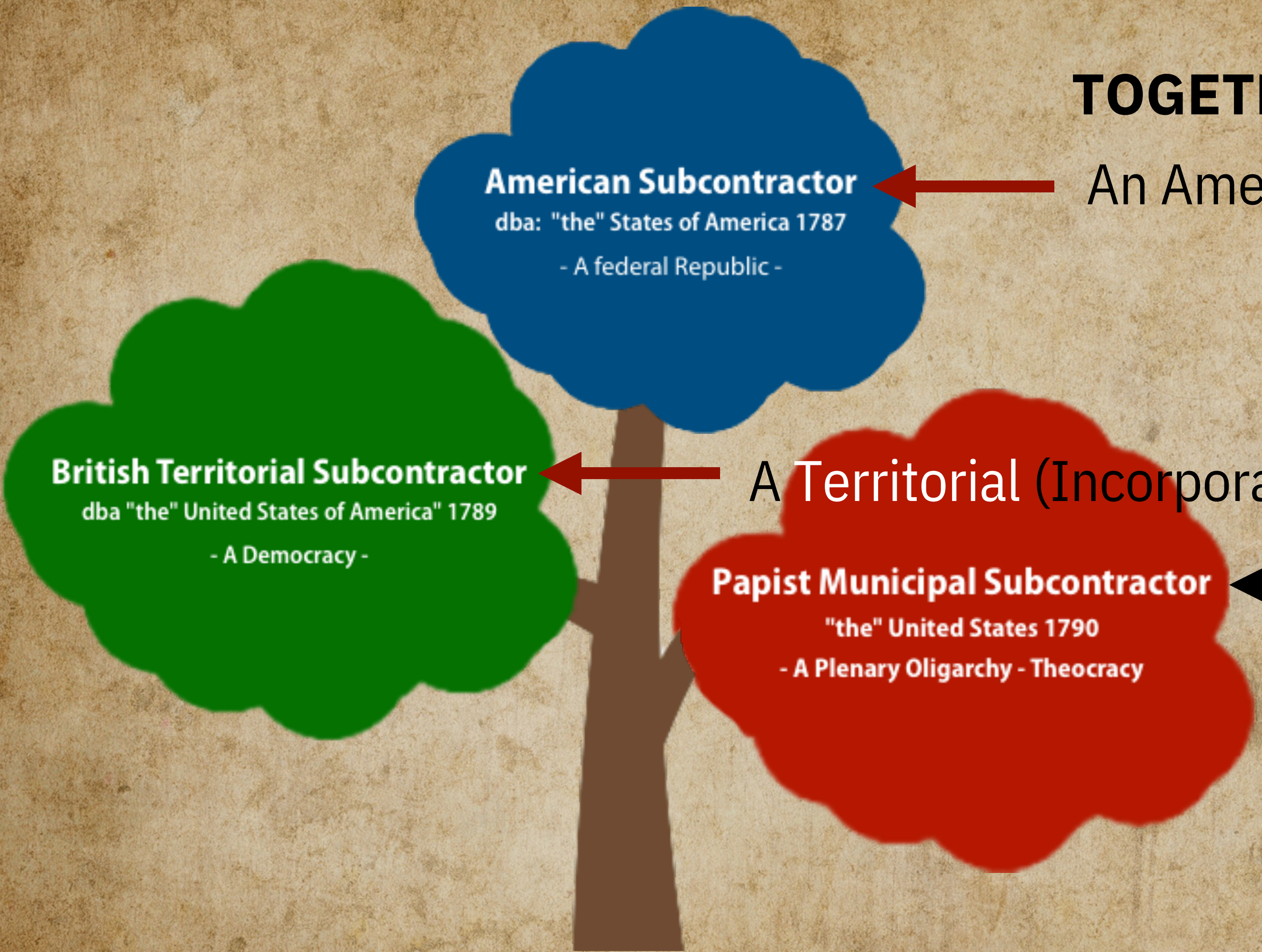

# The Constitution **for the united States of America** Part of **International Land and Sea Jurisdictions**

## **1. American Subcontractor**

- the "Virginia State," the "Maine State (Title Case)"
- Federal Legal Persons - United States Citizens
- With State Fiduciaries and Dependents
- "Vacant" Offices periodically filled by "Representatives"
- This branch has been missing since the 1800's
- This will be Reconstructed
- No Titles of Nobility, Bar Attorneys, nor Political Parties
- It is a **Continental Congress**
- Publishes on the Congressional Record
- Consists of **Postal Area Courts & Article 1 Courts**
- Uses United States Statutes-at-Large and Organic Law
- via International Land and Mercantile Law

- Hires the Fully-Named Agencies Departments
- With Navy, Tariffs and Trade Policies
- Northern Mercenaries in the Civil war
- Bar Attorneys and Political Parties Allowed
- Is the **United States Congress**
- Publishes upon the Federal Register
- Has Judicial District Courts
- Uses Federal Code and Statutory Law
- Via Admiralty and Equity Law

### **3. Papist Municipal Subcontractor**

- With Federal Civil Service and Dependents
- Hires the Alphabet-lettered Agencies/Departments
- Is the Washington DC Municipal Government
- Southern mercenaries in the Civil War
- Bar Attorneys and Political Parties Allowed
- Known as US CONGRESS
- Publishes as Municipal Code and UCC
- UNITED STATES DISTRICT COURTS
- Uses Municipal Law and Uniform Commercial Code
- Via Roman, Civil, Global Commercial and Maritime Law

- A Plenary Oligarchy - Theocracy

If you want to claim you

You **can not act** as any kind of **Federal United  
States Citizen** at the **same time** as you  
**participate in your assembly.**
