International Public Notice: Demand to Shut Down of All Foreign Guild Organizations

All foreign guild organizations which have been put in place under the auspices of an illegal mercenary occupation of our country must be shut down permanently and suffer liquidation of their assets.

Earlier this week we required the closure and decampment of the District Courts and their State of State and State (Trust) Court franchises as organizations engaged in known criminal racketeering and fraud upon the American Public.

These foreign courts must return to their proper location in the District of Columbia and function in their intended role and jurisdiction exclusively.
