The United States of America-Federation of States



International Public Notice: A Letter to Inform Dr. Henderson and the Universal Court

Enter His Gates with Thanksgiving and His Courts with praise." Psalm 100:4.

Let it be clear that we, personally and individually, have made peace with Dr. Henderson; let it also be clear that there are numerous misunderstandings that continue to cloud the issues.

In the teleconference aired last night by Dr. Henderson, August 7th 2025, the nature of those misunderstandings became very apparent.

1. The "US" is not America. It never has been. And 90% of what Dr. Henderson was describing as "the United States of America" and activities of "the United States of America" ---isn't American, either.

2. There are two separate entities being represented by the same words.

There is The United States of America, our unincorporated Federation of States, which is American.

There is "the United States of America, Incorporated" which is a British Territorial (British Crown) Corporation, which is not American.

3. We believe Dr. Henderson is a fair man, and he would not knowingly or willingly lie about anything to anyone, so his references to "the United States of America, Incorporated" as if it was The United States of America, our Federation of States, is clearly a mistake and unfortunately, it is a common mistake.

4. Our country in international affairs is supposed to be represented by our unincorporated Federation of States, The United States of America, not by our British

Territorial Subcontractor calling itself "the United States of America--- Incorporated", so if you want answers, you need to ask the right people, the correct version of "United States of America". Dr. Henderson and the government corporations running 198 other countries have been talking to Donald Trump about matters he has no knowledge of and which he cannot address even if he wanted to.

5. The idea expressed by Dr. Henderson that our country has no gold, no silver, no actual assets is also a mistake; the truth is that our British Territorial Subcontractors have virtually no assets of their own and are contractually obligated to subsist on our credit. That's why they keep trying to front commercial paper and digital currencies and can't seem to produce an accurate balance sheet. They literally can't do what Dr. Henderson and the Universal Court requested, because all they know is the credit-debt system they are dependent on. It's like asking a gardener working under contract to account for his employer's holdings. How would he know? All he has is a credit account that he charges for his supplies and wages.

6. This brings us to another point of misunderstanding. Americans don't live under the Federal Constitutions. The Federal Constitutions are for our employees. They are self-evidently employment service contracts, which define the roles of the employees, the services to be provided, and the limitations of the contract. The phrase, "We, the People", refers to our State Citizens operating as Lawful Persons in International Jurisdiction. These State Nationals are the Principals guaranteeing payment and holding enforcement powers over these service contracts, but for many years our States were not in Session, and the Constitutional contracts lacked immediate enforcement as a result. Our States have been in continuous Session since 2019 and have been exerting steady force to reform the operations of the Federal Subcontractors and the so-called "United States Trustees".

7. As it is self-evident that the Federal Constitutions, all three of them issued sequentially in 1787, 1789, and 1790, are all services-for-hire contracts, we are at a loss as to why anyone would mistake these subcontractors for our actual government. It is, nonetheless apparent, that a great many people, including Dr. Henderson, have made that mistake.

8. Dr. Henderson also said that we have no viable currency; that is another mistake. We have the United States Silver Dollar still in circulation, and recently issued the American Federation Dollar, which is gold-backed for purposes of international trade.

9. We wish to clear up the debate about "birthright citizenship", too. The key word is "citizen". A citizen owes service to the government and "citizen" is the common status of all our public employees and asylum seekers; obviously, most Americans are not public employees and not seeking asylum with any foreign corporation, and are not citizens as a result.

Birthright citizenship is a form of indentured servitude or enslavement common to European monarchies and the Holy Roman Empire. It refers to British Territorials living in this country and to servants of the Pope here on assignment, not to Americans.

Americans have no obligation to serve any government at birth, and must be fully of age before they can voluntarily accept any such obligation.

10. Habeas Corpus was suspended by Abraham Lincoln in 1863 and has never been restored; this entire country has been under an illegal mercenary occupation ever since. We are not alone. The same tricks have been played on many other national governments.

11. Dr. Henderson is correct that all incorporated entities (not merely "corporate", but "incorporated" entities) belong to the Vatican, or more specifically to the Roman Curia, and the Pope is responsible for their discipline under Ecclesiastical Law. Let us make a clear distinction -- a lawful government is corporate in nature; like a Mom and Pop family business, it has a Business Name, but it is not chartered by any other government, nor registered, nor licensed by any government. Such a "corporate but unincorporated" business does not make use of any of the business models created by the Roman Curia (and therefore owned by the Roman Curia) such as S-Corps, B-Corps, C-Corps, Non-Profit Corporations, Foundations, Cooperatives, Limited Liability Partnerships, etc.

Obviously, the Pope failed his obligation under Ecclesiastical Law to discipline, and when necessary, liquidate the corporations that he owned for their numerous crimes.

12. The Pope never owned the "corporate, but unincorporated" independent businesses and that includes unincorporated governments, such as our unincorporated Federation of States.

13. We should point out that "the US of A, Incorporated" that Dr. Henderson repeatedly referenced is a British Crown Corporation, and that "President" Obama was the president of that incorporated entity in the same way that Jeff Bezos was "president" of Amazon, Inc. Any stealing of funds that went on and any acceptance of an \$875 Billion dollar loan by Obama was clearly misrepresented to Dr. Henderson as a loan to this country, when in fact the similarly named foreign corporation received and squandered it, and it is the responsibility of the British Crown to repay it. As Dr. Henderson readily observed and admitted, none of it went to relieve the people of this country, nor was it spent on our infrastructure needs.

14. Doctor Henderson repeatedly referenced the "melanated nations" as if some people are not "melanated", but in fact, all living people (except rare albinos) have melanin and

are "melanated", including so-called "white people". It's just a matter of more or less of this pigment in the skin which gives rise to the diverse coloration of mankind.

15. Doctor Henderson also repeatedly refers to the "five unincorporated nations" and describes them as diverse variations of black ancestors who gave rise (his version) to the Chinese, Russians, and others. Again, we don't think he is lying about anything on purpose, but the five families of mankind exist because they each inherited a different brainstem and autonomic nervous system, which derive from genetically engineered borrowing from reptiles -- lizards, turtles, and snakes, fish, and amphibians. This is readily observed by biopsy of the medulla oblongata. Moreover, this genetic engineering took place in Mesopotamia and Turkey, where bas relief carvings in stone preserve this history--- and it all occurred long before the Twelve Tribes of Israel existed. So this, too, is a misunderstanding that needs to be cleared up.

16. Dr. Henderson maintains that the Treaties signed by "the United States of America" -- Incorporated were no good and dishonored; this is true. The incorporated entity calling itself "the United States of America" couldn't form a valid treaty --- nor could any other incorporated entity; instead of land jurisdiction treaties of the kind expected by Dr. Henderson, such incorporated legal fictions create "sea treaties" which are little more than Memorandums of Understanding between the Parties--- and these can be broken via a simple notice of declaration or liquidation.

This is why none of the Native American Treaties were honored -- first by King George, and later by the British Territorial Blue Coats that made treaties with them. The treaties themselves were flawed upon issuance by deceit and misrepresentation and non-disclosure.

This is not a reflection upon "the Americans" but is a black mark against the British Crown (again) and the British Monarchy and those British Territorial Officers who made these "treaties" in bad faith.

17. Dr. Henderson notes the "Jubilee Bill" that he authored and presented to the United States Congress, only to see it dallied with, and only to observe that the late Queen Elizabeth used the receipts to reward her loyal retainers and never let the common people have any kind of Jubilee at all. This is because, like her predecessors, she considered her subjects to be of two kinds --- slaves and indentured servants, neither one of which rated sharing in a Jubilee.

It's important that Dr. Henderson-- and the rest of the world-- understands that the "USA" he constantly refers to is British, not American. And Americans are not on the hook to pay off British Territorial debt. That's why we haven't paid the debts that Dr. Henderson refers to. Those debts are King Charles III's and the Pope's responsibility, as their British Crown and Municipal Corporations are responsible for impersonating the

Americans and the American Government and running up the debt "in our names", much as any credit card hacker or identity thief might.

18. Dr. Henderson alleges that there were no "white people" on this continent prior to the arrival of Europeans in the 1400's, and that no treaties exist between the Native People of this continent and the Europeans --- but this is grossly untrue.

The Mound People of Cahokia built some of the largest villages ever constructed on this continent --- and they were demonstrably white and red-haired and were here between 15,000 and 10,000 years ago.

Even more to the point, the Armorican people of Normandy, France, established Blood Treaties with North American Native Tribes that stretch from the Mik-Mak ancestors in Canada to the Seminole ancestors in Florida and all the way west to the Iroquois League, Ojibway, the Lakota, the Mandan, Ute, and as far south as the Comanche and Navajo. In very ancient times, there were no written treaties. Treaties were established between different nations by marriages. These Blood Treaties predate modern diplomacy but must be recognized in the DNA record that is preserved and which shows interaction and intermarriage between the Armoricans of northwestern France and the Native American Tribal People going back at least two thousand years and possibly much longer.

Less lasting Blood Treaties have been memorialized at campfires and meeting places by the simple act of cutting both parties' hands and commingling their blood in an unbreakable pact, a custom that is familiar to every American schoolboy to this day.

This is why the Europeans called this country "America" -- it's an Anglicized transliteration of "Armorica".

We believe that Dr. Henderson is a fair and honest man, and presented with the DNA evidence and other archeological evidence, will agree that white men were here as long as anyone else that can be traced and shown to be living here, and there is, therefore, no just or supportable excuse for excluding white men from living here now.

We remind Dr. Henderson and all greedy 198 incorporated franchises salivating behind him that the history of mankind is one of deceit and of becoming what we hate, instead of what we pretend to love. If it's not good for everyone, it's not good. Agreeing to enslave one man throws open the door to enslaving all men.

19. All the hatred and impatience and righteous indignation against "Americans" is misplaced, because the actual Americans have been abused, pillaged, and plundered like everyone else; the emotional ire should be directed toward the source of all these

injustices, prejudices, and evil acts, because they have been perpetuated by the Tories -- the British Territorial traitors to this country who have commandeered its resources and lied to and suborned its people in breach of trust and under color of law since the days of Abraham Lincoln.

It is worth noting that Lincoln's Emancipation Proclamation did not free the black plantation slaves; it freed the white plantation owners from their legal obligation to provide food, water, shelter, and clothing to those same slaves --- with the result that the suffering of plantation slaves greatly increased after Lincoln's "emancipation".

This is an example of the twisted history that we are all heir to, and the many misunderstandings that still exist.

20. Among the other evil deeds of Abraham Lincoln, he unlawfully converted the American Military into a private commercial corporation's Mercenary Force -- without telling the Americans, of course. To this day, our sons and daughters have been "inducted" and even "drafted" under force and color of law, and have been lied to and induced to sign contracts of indentured servitude to serve "tours of duty" --- all without being told anything about the nature of this duty and the fact that they would be serving as mercenaries for hire.

Instead, these innocent young people were inspired by phony patriots to enlist in this foreign service, akin to the French Foreign Legion, all to the tune of Yankee Doodle Dandy.

Thanks to the Public Fool System institutionalized in the wake of the so-called Civil War, most of those young Americans believe that they grew up in a democracy and that they are fighting for that democracy, when in fact this country has never been a democracy. That's the British Territorial "United States" instead --- what most people think of as the US Territories and Possessions.

America, which has been set up as the scapegoat and the whipping boy for all the British violence and war-mongering, lying, cheating, and injustice --- is in fact among the other victims, and has suffered illegal occupation by British-led Mercenary Forces for over 150 years. They've collected their pay from our pockets while doing it, and used our sons and daughters as their cannon fodder, too.

We aren't proud to admit that we've been so clueless that they got away with this for so long, but then, most of the rest of the world has been deceived just as well.

21. Dr. Henderson -- ask yourself, how is it that America enjoyed an excellent reputation for honesty and good business practices that lasted right up until the Monroe Doctrine --

but then mysteriously, circa 1907, its government became a cesspit of intrigue and payola and violence? Deceit and immorality? And war-mongering?

1907 corresponds with the bankruptcy of the first British Crown corporation impersonating our lawful government: the Scottish Commercial Corporation founded in 1868 and doing business as "The United States of America" --- Incorporated, which blatantly impersonated our unincorporated Federation of States.

When that corporation went bankrupt and left its creditors to mourn, a process was set in motion that resulted in the First World War.

When "the United States of America" Incorporated --- another British Crown corporation impersonating us went bankrupt in 1933, a process was set in motion that resulted in the Second World War.

And now, the UNITED STATES, INC., a Roman Municipal Corporation, has gone bankrupt in 2015 --- they are three years off target for starting World War III.

How clueless can we all be? These evil men are impersonating entire nations using similarly named corporations, and using bankruptcy fraud to cheat their creditors and indebt their unwitting employers.

How could you, Dr. Henderson, imagine that Washington, DC, was our capitol, when we have always carefully described it as "the Federal Capitol" -- designated as the Capitol of the District of Columbia?

The American Capitol is Philadelphia -- the City of Brotherly Love.

Why would you or anyone else go looking for the American Government in Washington, DC?

Isn't it plain enough that our government hired these people, including the foreign subcontractors, to provide "essential government services" under Article IV of each Federal Constitution?

Why look for their employers in a city created to expedite our subcontractor's operations? Why would we be there?

For, surely as you stand here and wonder why "the Americans" haven't answered the rest of the world, the Americans haven't been addressed yet and told what's going on ---

a situation all the more perplexing, since we met with you over a decade ago, and had an amicable meeting.

22, Donald Trump is "President" in exactly the same sense and office as Abraham Lincoln --- that is to say, that he is operating as the "President" of the United States of America, Incorporated, a British Territorial Crown Corporation that isn't "American" at all, even though many of its employees were born in this country and live here under the Residence Act.

23. That this is so can be directly observed. Despite efforts to remake and rebuild this country so as to make it profitable again and settle down the "ungrateful natives" in the words of Queen Elizabeth II, Donald Trump is following the policies and dictates of the same old Anglo-Dutch Alliance, not the American Government.

For example, our American Government stands firmly opposed to genocide and meddling and war-mongering of any kind, so of course we have spoken against the carpet-bombing of Gaza and the continuing genocide of Palestinians, of course we have spoken up against what you call "American" but which in fact are "US" arms sales to Ukraine. These are not American initiatives that Trump is pursuing. These are British Crown initiatives and Trump is a British Crown Officer. His ancestor, Martin Tromp, was an Admiral in the Dutch Navy.

If you want to pin the tail on the right "donkey" realize that the source of all the war profiteering and misery of the past three centuries isn't America. It's the British Territorial United States that has been using us as a storefront and deceiving the entire world.

24. And if you want a Biblical interpretation, Britain is the beast from the sea and the British Empire was the resurrection of the Roman Empire -- the Beast that died and came back alive. America is not Edom, but in the Jewish tradition, was descended from Mannasseh, whose Father was Joseph, and whose Grandfather on his Mother's side, was Potipher, the Egyptian High Priest. We are the ones who inherited the wealth of nations and who are destined to serve as the Storehouse of the Lord.

25. Which brings up another issue to date --- the total lack of comprehension of just how vast our resources and the planetary resources are. You speak of trusts and interests worth 47 Trillion dollars and 57 Trillion dollars respectively, but the actual owners (that word, "owners" means "caretakers") hold unimaginably more wealth than this.

To give you an example, in a single transaction which occurred in April of 2017, the GOVERNOR OF OTTAWA (a Roman Municipal Corporation) paid Prince Philip \$950 Trillion dollars worth of "Life Force Value Annuities". Three days later, Prince Philip

retired from Public Life. Go figure. That is a single transaction -- a large transaction, but just one of many.

A single large family trust held by an American who also claims divine blood and lineage holds 2.4×10^{24} in gold and silver and land assets. His holdings have long underwritten the entire Central Bank System of the world.

This is the kind of knowledge that we have and the depth and breadth of resources that we bring to the table -- which may be another reason that our run amok employees have not tried to answer Dr. Henderson. They don't know all the details, but they certainly know that our holdings vastly exceed a hundred trillion dollars, so they are keeping their mouths shut, thinking that they won't have to share with the rest of the world.

26. Fortunately for everyone, the Russians have a treaty with us formed in 1858, the American-Russian Alliance; this has led to the Russian Government protecting us, the actual American Government, on numerous occasions, even after the Communist takeover. The Russians are scrupulous, serious-minded people, and they will confirm what we tell you is true. They can confirm that our government has been commandeered by British Territorial commercial mercenary forces acting under conditions of deceit and color of law for over 150 years.

So will certain members of the offending governments -- members of the House of Lords and Privy Council, members of the Order of the Garter, and the Knights of Malta are aware of how they have snookered and abused us and our entire country.

27. The way to deal with this is to treat it as a criminal matter and arrest and prosecute the criminals --- who are not actually Americans, even though many of them have been born and raised here as "residents" allowed to be here via the provisions of the Residence Act.

If you research it, you will find that both Abraham Lincoln (Lincolnshire) and General Ulysses S (Hiram, aka, US GRANT) Grant were descended from British Tories who lost a lot of property as a result of King George's defeat in the War of Independence.

They were part of a collusion between the British Crown and the Roman Pontificate to undermine their American Employers in Breach of Trust and commercial Bad Faith, an agreement memorialized as the 1829 Treaty of Verona.

28. Dr. Henderson, you have cause to know that Americans are not bad people. If they were, where would you be right now? Most Americans outside the District of Columbia are color blind and aligned with the diversity we see reflected throughout creation.

How many kinds of trees are there? How many different birds and butterflies? Nature's God is a God of laughter and abundance and balance and joy; Nature's God delights in different colors and sizes and shapes. And so do we. Like Joseph's Coat, we are a nation of many colors, many cultures, many traditions, many religions.

Americans, actual Americans, fought for five long years to end slavery. It wasn't our fault that it wasn't abolished.

Observe what happened: the anti-slavery forces won, the plantation slaves were set free and promised "forty acres and a mule" as a grubstake.

And then, the British Territorial U.S. Congress issued the Fourteenth (ByLaw) Amendment to a phony "Corporate Constitution" they cobbled up as the charter for the Scottish commercial corporation misrepresenting itself as "The United States of America" ---Incorporated.

With the Thirteenth (ByLaw) Amendment, they abolished slavery, and with the Fourteenth (ByLaw) Amendment to this Corporate Constitution, they redefined and institutionalized slavery, by arbitrarily conferring "citizenship of the United States" on the former plantation slaves.

Private slave ownership was outlawed, but public sector slave ownership had just begun.

By 1965 we were just about all enslaved, forgetful of who we are, no longer raising our eyebrows when people described our country as a democracy, no longer holding our public employees accountable.

Like Native children kidnapped and forced to go to "Residential Schools" -- to transform them into nice little British Territorial Residents, generations of Americans have been viciously and selectively groomed and indoctrinated in British Territorial Public Schools, where we were forced to "swear allegiance" to a flag they borrowed from us and which they lavishly abused, were told that our government was a democracy, told that we were United States Citizens, and also told that we were Taxpayers. None of which is true.

29. So, in the name of the True God, pay attention world, and pay attention Dr. Henderson, to what we are telling you; because the Brits don't give a good damn about America. They are more than willing to sacrifice us so long as it saves their hides and lets them escape the come-uppance they so richly deserve. They have planned with malice aforethought to use us as the universal scapegoats and to offer our land and our assets to their creditors.

There's just one problem. They don't own any land in this country. Not a cubic centimeter do they possess, and they cannot give what they don't have. We own the cadastral survey and the original land grants that stand above all land patents, descriptions, and titles.

As Witness to this, the late British Queen Elizabeth II, agreed to sell her "tribute interest" in American gold to the Chinese. By treaty agreement, the British Monarch is supposed to get a one tenth share of all gold mined in America. The Chinese Government geared up, and prepared to bring massive mining equipment to our shores and begin mining operations in this country --- in search of the Queen's Tribute Share.

But this was stopped because while the Queen was owed a tenth of all the gold mined within our borders, she was never owed a single centimeter of land or soil. She and the Chinese would just have to wait until we mined it.

30. Let us suggest that the time is long overdue to meet again; for you to tell us what you have learned and for us to share what we have learned, and in the immortal words of Chief Sitting Bull, "Let us put our minds together and see what kind of life we can make for our children." And open the Lion's Gate.
