International Public Notice: Full Circle

It has been eleven years, five months, and nineteen days since I sent my Letter to Cardinal George of Chicago. Today, that demand for solace and redress and justice for the living people has been answered by the High Courts of the world.

British Subjects and Municipal citizens of the United States ---the imposition of dozens of taxes on our weary backs is over.

It's over, and you have lived to see it.
