same time.




Every living man is a state unto himself and within himself has:


- his “land” (*bones and flesh*)



Most famous example of Land Law is **The Ten Commandments**


Second most famous example is the **Federal Constitution** issued in 1787.

Admiralty Law.




Maritime Law

Law Merchant.




Each country has

Admiralty Law.


**The British

estates.**




The American Admiralty Law

the land.




The Municipal PERSONS are formed as franchises of the Municipality of Rome. They are also “dead” and sojourn in the **global jurisdiction** of the air.



These **PERSONs**
function under
Canon Law and
Ecclesiastical Law
and
“the **Law of the City**”
meaning
Municipal Code.



The **PERSONS** are subject to **Municipal Code**, the Municipal Code is subject to **Ecclesiastical Law**, and if there is a Church Official involved additionally subject to **Canon Law**.
